Please read the following instructions carefully and follow the same

1. Reporting :

You have been allotted IIIT Vadodara through the process of admission conducted by the Centralized Counselling for M Tech (CCMT - 2022)

- **You are required to report to Institute as per CCMT guidelines (Currently from 11th August, 2022 to 18th August, 2022 on working days).**
- **Classes will be commence from 22nd August, 2022.**
- Every student will be required to have her/ his own portable computing hardware (laptop / notebook) to carry out all the academic activities including classes, labs, assignments. The computing hardware will also be require for teaching assistanceship (TAship) duties assigned by the Institute.
- Detailed time-table and Google Meet link(s) for the classes shall be communicated in due course through Institute website.
- You will be assigned teaching assistanship during orientation process.
- Hostel is available for M.Tech students which is 17Km away. However staying at **Hostel is not mandatory for M.Tech students.**
- Classes will be held physically at Institute. Your presence is mandatory.

2. Documents:

You are required to bring the following documents for verification at the time of physically reporting at the Institute upon receiving official notification from the Institute authority. Till such time your admission is provisional.

- (a) Printout of the Registration form and the locked choices.
- (b) Provisional Seat Allotment letter downloaded from the CCMT website.
- (c) Self-attested copy of GATE scorecard (2020 or 2021 or 2022) as applicable for securing admission.
- (d) Photo ID proof as per Govt. of India norms
- (e) Original Birth certificate
- (f) Original Mark sheet of Class XII
- (g) Original Grade/Mark sheets of qualifying examination (composite grade card)



- (h) Original Degree/ Provisional certificate, if degree is awarded.
- (i) Original Certificate in support of reservation category (SC/ST/OBC), if applicable, as per Government of India notification, issued by the competent authority. in case of OBC category the certificate must be issued on or after April 1, 2022. Caste certificate of category (SC/ST/OBC) issued by Maharashtra state must be validated by Social Welfare Department (in case of ST category) of Maharashtra Government.
- (j) Undertaking by the candidate regarding OBC status in the required format
- (k) Original Certificate for Persons with Disabilities (PwD), if applicable, issued by the competent authority
- (l) Proof of payment of full fee of Rs. 63,870/- to CCMT.
- (m) Original Migration certificate of last Institute / University attended
- (n) Three colour passport size photographs
- (o) Original Conduct Certificate from the Head of the institution last attended
- (p) Original college leaving certificate/ Transfer certificate from the Head of the institution last attended
- (q) Original Course completion certificate from the Head of the University / Institute in case result is awaited in absence of degree certificate.
- (r) One set of self-attested photocopy of all the original documents.
- (s) Medical fitness certificate (Issued by a registered medical practitioner (Format attached).
- (t) Copy of Anti-ragging undertaking by Student and Parent.

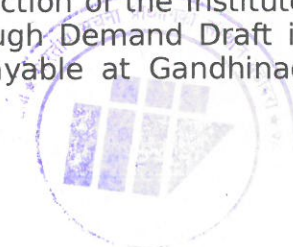
